## What is the Legal & General Relevant Life Mastertrust?

- Equity Partners or LLP members of a non UK partnership.
- Dependants' Pension benefits.

  - agreement between the trustees and an employer;
  - the giving of notice by the trustees to an employer;
  - notification by the trustees to an employer; or
  - consultation by the trustees with an employer

- any action that we take, or taken by any subsidiary or associated employer, which falls within the definition of discrimination under the Equality Act 2010, or a breach of the terms and conditions of employment, rests with the principal employer or its subsidiary or associated employer as appropriate; and
- the responsibility of the Mastertrust trustees is restricted to benefits that arise from time to time.
